# FREQUENTLY ASKED QUESTIONS (FAQ)

## Q: Am I eligible to receive this grant?

A: To be eligible to receive this grant, an applicant must:

- Be Interested in becoming a licensed Family Child Care provider with DHS
- Be able to meet all health and safety requirements necessary to receive and retain licensure

You may be eligible for this grant if you are a recently licensed Family Child Care provider, licensed a maximum 30 days prior to submitting this grant application

Previously licensed Family Child Care providers (that is, provider who are not currently licensed but have been licensed in the past) may also be eligible for this grant as they reopen their program, given their previous license was in good-standing at DHS.

## Q: When do I apply?

A: The application window will be open from October 3, 2022 to December 15, 2023. This program is first-come, first-served, so we encourage interested applicants to apply as soon as possible.

## Q: How do I apply?

A: The application link will be posted on <u>http://kids.ri.gov/cabinet/funding-opportunities/</u>. The application is hosted on a web-based tool called GrantsConnect. To submit an application, you will be prompted to create an applicant profile. ## Q: How much money might I be awarded?

A: One-time grants of \$2,000 will be issued to each approved applicant. Grant funds must be used to support programs with the following allowable costs associated with the licensure process:

- Quality improvement items
- Fire-related repairs and/or health and safety items (fire extinguisher, plug covers, etc.)
- Lead and radon inspections
- Liability insurance

## Q: Do I need to pay this money back?

A: This grant is funded through the American Rescue Plan Act (ARPA) State Fiscal Recovery Fund (SFRF), as appropriated by the Governor and the General Assembly, and as such, do not need to be paid back. However, DHS does reserve the right to recoup funds where a provider fails to maintain the terms of the grant application.

#### Q: What if I need help completing my application?

#### Q: How and when will I receive the funding?

A: There are two payment options: (1) Direct Deposit/ACH, or (2) Paper Check. DHS expects payments to be made within 30 business days of receipt of a completed application.

Electing to receive funds by check may delay payment up to an additional 30 business days due to processing and mail delivery. *Applicants are recommended to cash their check immediately upon receipt. Failing to deposit a check within 90 days will delay the release of funds.* 

#### Q: What are the tax implications of these bonuses?

A: Grant funds are subject to state and federal income tax, as they may be considered income. Taxes have not been withheld from the awarded grant funds. Please consult a tax professional or accountant for more information on how these funds may impact you.

#### Q: Why is the application asking me to submit my social security number?

A: A Social Security Number (or Tax Identification Number) is required in the application. This information will be used by Public Consulting Group (PCG, the fiscal intermediary disbursing payments) to issue a Form 1099-MISC. This tax form will be issued to all awarded applicants in January 2023 related to funds received in 2022, (or January 2024 for funds received in 2023), as these funds are considered income by the Internal Revenue Service.
